## **PROFESSIONAL EXPERIENCE**

#### ROOSEVELT UNIVERSITY (2022-PRESENT)

Roosevelt University (RU) is a private, nonsectarian, not-for-profit social justice university with a degree-seeking enrollment of over 4,300 students with a main campus located in Chicago's South Loop and a health sciences and STEM campus located in Schaumburg, IL. RU is a Hispanic Serving Institution, a Majority Minority Institution that primarily serves first-generation college students and students from low-income families.

# Provost and Executive Vice President of Academic and Student Affairs (Spring 2022 to Spring 2024)

Serve as the senior academic and student affairs officer and provide leadership and oversight for enrollment management; student success; advising; registrar; student housing; veterans affairs; the office of sponsored program and research; adult continuing education; first year success and transfer success programs; testing center; retention, tenure, and promotion; faculty and staff development; assessment and accreditation; honors, international services; and the Schaumburg campus.

## Selected Accomplishments:

- Facilitated a comprehensive reorganization of academic and student affairs in the first year, reducing the number of colleges from five to four, reorganizing the Chicago College of Performing Arts, and better aligning student affairs and student supports with academic affairs, resulting in a 2% improvement in freshmen retention and playing a major role in a \$9.873 reduction in overall expenses and closing a budget gap from \$13.9 million to \$4.6 million.
- Led Board of Trustees Organic Enrollment Growth Taskforce, reorganized enrollment management, and overhauled approach to enrollment and retention resulting in the following:
  - two consecutive years of 300 plus gains in overall enrollment; new students rose from 1,056 to 1,565
  - Students living in residence halls increased from 655 to 845; overall enrollment rose from 3,725 to 4,368
  - Freshmen retention increased by 2%; Freshmen discount rate reduced from 59% to 28%
  - Freshmen enrollment increased from 408 to 640, the latter an all-time record; new transfer students numbers increased from 358 to 459
  - New graduate student numbers increased from 290 to 536;
  - International student numbers increased from 162 to 519 (all-time record) Veteran and military connected student numbers rose 250%; size of the Honors program increased by 75%; domestic masters increased from 257 to 345; the fall doctoral class doubled.
- Wrote \$21.77 million in successful grants, Roosevelt University, (including \$5 million for RU Prime's Mentoring Ecosystem, Veterans, HSI, and McNair), 2022-2024
- Led efforts supporting 14 RU students in attaining IBHE Diversifying Higher Education Faculty in Illinois (DFI) scholar fellowships; established the MOCA (Men of Color Ascending) mentoring program.
- Reorganized Provost Office staff to restart institutional and program assessment process resulting in a positive HLC review with no findings for a focused visit on assessment; program assessment includes a special low-enrolled program review process, granting programs the ability to reorganize and rewrite their program in order to improve student numbers.
- Designed and launched 6 new academic programs: Business Analytics MS; Health Informatics MS; Interdisciplinary Leadership Ed.D.; Theater Studies BA; Arts, Entertainment, and Media Business BA; and Interdisciplinary Studies BA in Business, Criminal Justice, Healthcare Administration, and Psychology aimed at adult degree completion.
- Created a new University Center at McHenry County College; expanded program offerings of University Center at Harper College; established an advisory board for the Schaumburg Campus plan; became part of Blue Cross Blue Shield's Blue University; signed Honors articulation agreement with the City Colleges of Chicago; signed Star Scholars articulation agreement with the City Colleges of Chicago for IT and Computer Science; established relationships with Kimyo International University in Tashkent, GEMS B School in India, and the University of Santo Tomas in the Philippines; and designed a cybersecurity certification program with Security Meter.
- Chaired the Enrollment, Marketing, and Retention Taskforce resulting in numerous process improvements and efficiencies.

## **GOVERNORS STATE UNIVERSITY (2012-2022)**

Governors State University (GSU) is the only public regional comprehensive university located in Chicagoland's south suburbs, serving approximately 4,600 students. GSU, originally an upper-division university, is a Minority Serving Institution and an Emerging Hispanic Serving Institution and is well known for its Dual Degree Program, promoting a seamless education for transfer students, as well as the Nathan Manilow Sculpture Park.

## Dean, College of Arts and Sciences (2016 to 2022)

Serve as the senior academic leaders of the college with an annual \$11 million budget, proving leadership for the Center for Performing Arts; Visual Art Gallery; Biological Field Station; Center for Community Media; the Nathan Manilow Sculpture Park; the Institute for Politics, Public Service, and Social Justice; Forensics and Robotics Teams; and two academic divisions: Science, Mathematics & Technology and Arts & Letters.

## Division Head, Division of Liberal Arts (2011 to 2012)

Supervised the administrative team of the division, including 6 program coordinators (Communication Studies, English, Sociology, History, Continuing Studies, and Affiliated Programs) and led the development of a 5-year division strategic plan.

## CALIFORNIA UNIVERSITY OF PENNSYLVANIA (2004 to 2011)

Located in the largely post-industrial Monongahela Valley at the edge of Appalachia, California University of PA (CALU but now Pennwest California), CALU was a predominantly white institution with an enrollment over 10,000 that primarily served first-generation and low-income students, many of whom had never set foot in nearby Pittsburgh.

#### Interim Director and Assistant Director, Honors Program (2008 to 2011)

Oversaw the residential Honors Program that served over 300 students, including the recruitment of new students, chairing the Honors Program Council, and the redesign of curricular and co-curricular offerings.

#### Selected Accomplishments:

- Oversaw the creation of a student-led Honors Newsletter aimed at the university community and Honors alumni and collaborated with Advancement to assist in the receipt of a future gift of \$1.95 million by G. Ralph Smith II, for whom the Honors residence hall has been renamed.
- In collaboration with the Provost's and President's Office, developed an online dual enrollment program for high achieving Pennsylvania high school students.
- Wrote program mission, goals, and learning outcomes (heavily focused on experiential learning) and led our team's first-ever measurement of program outcomes.
